We respect your right to privacy. This Privacy Policy (the "Policy") explains how we, the team behind lawguard.llc, collect, use, store, and protect the personal data of users who interact with our website.

1. General Provisions

lawguard.llc is an informational online resource that gives users an opportunity to receive consultations on legal assistance, including matters related to recovery of funds from dishonest brokers.

In our work, we attach great importance to the confidentiality of information entrusted to us by website visitors. All information you provide is processed in strict accordance with the legislation of the Republic of Kazakhstan and international data-protection standards.

2. What Data We Collect

When using the website, users voluntarily provide the following data:

- last name, first name, or nickname;
- phone number for contact.

Data is provided only through the contact form on the website. We do not collect excessive information and do not use hidden methods to obtain it.

3. Purposes of Processing Personal Data

We collect and process personal data only for the purposes for which you provided it, namely:

- to establish contact with you;
- to conduct a preliminary analysis of your situation;
- to provide a free legal consultation;

- to inform you about possible ways to receive assistance;
- to improve the quality of our service and the processing of inquiries.

We do not use your data for marketing purposes without your consent. We do not sell or transfer your data to third parties.

4. Third-Party Services and Cookies

The website may use standard internet technologies, such as cookies, for the following purposes:

- to ensure correct operation of the website;
- to analyze traffic using tools such as Google Analytics;
- to improve user interaction with the website and increase its performance.

This data does not allow us to identify you, but it may be used for analytics and advertising systems, including Google Ads.

You may disable cookies in your browser settings, but this may affect the operation of certain website functions.

5. Legal Basis for Processing

We process your data solely on the basis of your voluntary consent, expressed by submitting data through the forms on the website. By submitting an inquiry, you agree to this Policy and give permission to use the information for the purposes described above.

6. Data Storage and Protection

We take all reasonable and technically justified measures to protect your personal data from:

- unauthorized access;
- disclosure;
- modification;
- destruction.

Data is stored on protected servers and is not transferred to third parties, except in cases directly provided for by the legislation of the Republic of Kazakhstan.

7. Your Rights

You have the right to:

- request access to your data;
- request correction or deletion of your data;
- withdraw your consent to data processing;
- file a complaint with the authorized personal data protection authority.
